PLEASE READ CAREFULLY. This Terms of Use Agreement ("Terms of Use") applies to use of the Bulgerlock.com website located at <http://www.Bulgerlock.com> (the "Site"). 4. Information reasonably sufficient to allow us to contact you, such as your address, telephone number and e-mail address;
5. A statement by you that you have a good faith belief that the disputed use of the material is not authorized by the copyright or other proprietary right owner, its agent, or the law; and
6. A statement by you that the above information and notification is accurate, and under penalty of perjury, that you are the copyright owner or authorized to act on behalf of the owner whose exclusive right is allegedly infringed.

12. Additional Terms. The following policies are incorporated into this Agreement by reference and provide additional terms and conditions related to specific services offered on the Site: Each of these policies may be changed from time to time and are effective immediately after we post the changes on the Site. You consent to the exclusive jurisdiction of the state and federal courts sitting in King County, in the State of Washington. This Terms of Use is personal to you and may not be transferred, assigned or delegated to anyone. Any attempt by you to assign, transfer or delegate this Terms of Use shall be null and void. Bulgerlock.com may freely assign this Terms of Use without consent or notice.
